**Mr. Herb Joslin and Mr. Frank Benell are not present for today's meeting. William Lepore, Chairperson, called the meeting to order at 9:35 am.**

**Mr. Lepore asked if everyone had an opportunity to review the minutes of the March 2006 meeting. Mr. Racine made a motion to approve the minutes as submitted. Mr. Davies seconded the motion. All members voted in favor.**

**Mr. Lepore introduced and welcomed Mr. Keith Burlingame to his first meeting as a member of the Board of Examiners of Electricians.**

**There are three (3) appeal hearings rescheduled from the April for today for which there is a board stenographer. There was no quorum at the April meeting. However, on the advice of counsel, testimony was provided by the following appellants and complainants.**

- 1. Cacia Electric – Violation # 2624**
- 2. Cacia Electric (Michael Lussier) – Violation # 2625**
- 3. Cacia Electric (Ryan Geremia) – Violation # 2626**

**RIDLT Investigator Mr. Glenn Dusablon referred the board to the official minutes of the April 19, 2006 meeting which includes the testimony of the appellants.**

**Mr. Racine stated that he was present last month to hear the testimony regarding these violations and based on that testimony a finding of fact was made that Cacia Electric did have two unlicensed employees performing electrical work in North Smithfield, RI without valid RI electrical licenses and based on the fact that an admission has been made to suspend violation # 2624 for a 12-month period pending any further violations of RIGL 5-20. Mr. Durand seconded the motion. All members voted in favor.**

**For same above reason, Mr. Racine made a motion to suspend violation #'s 2625 and 2626 pending any further violations of RIGL 5-20. Mr. Davies seconded the motion. All members voted in favor.**

**This concludes the hearings.**

**There was no further business.**

**Mr. Durand made a motion to adjourn at 10:15 a.m. Mr. Racine seconded the motion. All members voted in favor.**
