

The Fire Safety Code Board of Appeal & Review met in Conference Room 109 at 260 West Exchange Street, Providence, RI on Tuesday, March 28, 2006 at 1:00 PM. Present were Chairman Farrell, Vice Chairman Coutu and Commissioners Blackburn, Newbrook, Preiss and Burlingame. Also present were Executive Director Thomas Coffey, Jr., Esq. and Assistant Administrative Officer Carol Marsella. The following appeals were considered.

Appeal #060165: Mr. Arn Lisnoff, for the property located at 100 Metropolitan Avenue, Cranston (Cranston Career and Technical School.) Deputy State Fire Marshal Cynthia Dehler and Chief Deputy Michael DiMascolo appeared for the State Fire Marshal's office. Commissioner Newbrook made a motion, seconded by Commissioner Burlingame, to accept the Applicant's plan of action for the existing wood mezzanine of this facility. The motion was unanimous.
