

The Rhode Island Fire Safety Code Board of Appeal and Review met at its headquarters located at 1 Regan Court, Varley Building #46, in Cranston, RI on Tuesday, August 6, 2013 at 1:00 P.M. Present were Chairman Newbrook and Commissioners Sylvester, Burlingame, Booth and Richard. Vice Chairperson Filippi and Commissioners Pearson, Walker, Thornton, Jackson and Blackburn were absent.
