Chairman Reynolds called the meeting to order at 10:37 a.m.

MINUTES: Chairman Reynolds made a motion to pass June 24, 2015 meeting minutes. Seconded by Mr. Gamba. All in favor.

OLD BUSINESS:

Total Loss Bulletin: Going very well. Still on going. Currently on hold due to email problems.

Salvage Rebuilder License: Question to the Board. During the salvage rebuilder inspection done at the Registry of Motor Vehicles, do they inspect the frame? Answer from the Board was Yes~~Yes~~. They do.

Complaints: Mr. Bottella asked the Department how many open complaints? Mr. Mancone stated that there were 5 in legal, with 2 going up to legal soon. Board would like update at next meeting also.

Regulatory Reform: Mr. Bottella, Per Executive Order 15-07, believes adding Salvage Rebuilder to the Auto Body Application would streamline the two processes and would be exactly what the Governor is looking for. Same application, with separate fees and license. A few Regulation requirements will need to be looked at by legal for a few changes.

NEW BUSINESS: Chairman Reynolds made a motion to activate a Subcommittee/fact finding group to work on shop classifications. Seconded by Mr. Gamba. All in favor. Chairman Reynolds spoke briefly on what the new law is requiring the Board to accomplish. He wants subcommittee to set minimum standard for B shops and add A shop new requirements. Subcommittee volunteers were named as Mr. Gamba, Mr. Bottella, Mr. Lauro, Mr. Ferranti Jr., and Mrs. Petraca.
