**The minutes of the meeting held September 16, 2005 were presented. On motion by Terrance Giblin, seconded by James Pinel, it was unanimously voted to accept the Open Session minutes as presented.**

**Members reviewed a communication from NBCC stating the clinical**

**portion of the national certification exam used for licensure in Ohio, while different in format/administration, it tests similar mental health counseling knowledge, skills and abilities. Further, the content of the exams for Ohio and Rhode Island is derived from the same job analysis. Board members unanimously agreed to accept applicants who have taken the Ohio NCMHCE.**

**The 2006 board meeting schedule was reviewed. The schedule will remain as is, pending the need for an increase or decrease in meetings.**

**Members reviewed a request from an applicant planning to seek Rhode Island licensure. The future applicant graduated from the University of Missouri with 48 credits, therefore, requires 12 credits for Rhode Island eligibility. The future applicant requested approval of a group counseling and counseling theory course from Providence College, which may be similar to courses she has previously taken. As the core curriculum does not address levels of coursework, i.e., introductory, advanced, etc., but denotes only the number of credits required, the request is approved.**

### **Adjournment to Executive Session**

**On a motion by James Pinel, seconded by Terrance Giblin, it was unanimously voted to adjourn to Executive Session pursuant to Sections 42-46-4 and 42-46-5 (a)(1)(4) of the Rhode Island General Laws, as Amended, in that confidential issues of fitness for licensure**

**and investigative cases will be discussed. Complaints addressed: MHC#3-2004, MHC#1-2005 and MHC#3-2005.**

### **Return to Open Session**

**The Open Session was called back to order. On motion of Dale Blumen, seconded by John Roche, it was unanimously voted to keep confidential all matters discussed in Executive Session and to seal those minutes inasmuch as fitness for licensure and ongoing disciplinary matters were addressed. Final action: RE: Complaint MHC/MFT#1-2005, by unanimous vote the Board proposed to revoke individual's license.**
