**1. Truck Solutions Sales and Service, LLC- First Application**

**DECISION: The board granted the first application of Truck Solutions Sales and Service,**

**LLC to deal in new "Hino" trucks and used motor vehicles only,**

**located at 125 Industrial**

**Drive, North Smithfield, RI. This application was granted with three dealer plates and**

**subject to the legal papers on the corporation being in order, and a site-inspection.**

## **2. Rastelli Truck & Auto Sales – First Application**

**DECISION: The board granted the first application of Rastelli Truck & Auto Sales to**

**deal in used motor vehicles only, located at 1 Log Road, Smithfield, RI. This application**

**was granted with three dealer plates and a site-inspection after the previous dealership**

**Interstate Truck & Sales transfers to their new location.**

## **3. Interstate Truck & Sales – Transfer Application**

**DECISION: The board granted the transfer application of Interstate Truck & Sales from**

**1 Log Road, Smithfield, RI to 2 Ambrose Street, Providence, RI.**

## **4. Apollo Auto Sales, Inc. “Annex” – Annex Application**

**DECISION: The board granted the Annex location of Apollo Auto Sales, Inc. located**

**At 623-625 Broad Street, Cumberland, RI.**

## **5. Prime Auto Brokers, Inc. “Annex” – Annex Application**

**DECISION:** The board granted the Annex location of Prime Auto Brokers, Inc. located at 347 Broadway, Pawtucket, RI.

**6. Sabets Auto Sales – Request For 2-Additional Dealer Plates**

This matter was postponed by the dealer.

**7. Portsmouth Auto Sales & Repair – Request For 2-Additional Dealer Plates**

**DECISION** The board granted Portsmouth Auto Sales & Repair the requested two

additional dealer plates, subject to maintaining the additional number of employees

to keep the additional dealer plates.

**8. Jennifer Mudd v Silver Lake Auto Sales – Show Cause Hearing**

**DECISION:** It was the board's decision to stay the suspension of Silver Lake Auto Sales

for 30 days to afford the dealer the opportunity to comply with the board's previous decision

of September 9, 2004. The board fined the dealer \$100.00 for failure to comply.

**9. G's Auto Sales – Show Cause Hearing**

**DECISION:** It was the board's decision to allow the dealer a 30 day extension to give

**definitive plans to expand the building. The board fined the dealer \$100.00 for failure to comply with the previous decision of April 10, 2003.**

**10. Iafrate Auto Sales – Show Cause Hearing**

**DECISION It was the board’s decision to fine the dealer \$100.00 for not complying with the board’s previous decision of October 9, 2003. The board allowed the dealer 30 days for completion plans and a construction contract.**

**11. Davis Assante v Ocean Nissan – Complaint/Show Cause Hearing**

**This matter was postponed by the Dealers’ License & Regulations Office.**

**12. Thomas E. Conte v Tasca Lincoln Mercury – Complaint/Show Cause Hearing**

**This matter was settled between both parties prior to the scheduled hearing. A notice of withdrawal is to be submitted.**

**13. Leeann M. Phaneuf v All Star Auto Rental & Leasing – Complaint/Show Cause Hearing**

**This matter was settled between both parties with a notice of withdrawal to be submitted.**

**14. Arthur Santos, Jr. v County Motors, Inc. – Complaint/Show Cause Hearing**

**DECISION:** It was the board's decision that the dealer reimburse Mr. Santos the sum of \$129.91 for repairs done to his vehicle. Mr. Santos has a valid contract.
