Please be advised of the following matters which were heard before the board on Thursday December 15, 2005. Also be advised the following people were present during the hearings: Joseph I. 1. Speedcraft Chrysler Dodge. – First Application

DECISION: The board granted Speedcraft Chrysler Dodge the first application to deal in new Chrysler and Dodge motor vehicles and used motor vehicles only located at 84 Old Tower Hill Road, Wakefield, RI 02879. This application was granted subject to a site inspection, and a new surety bond, photos and certificate of insurance being delivered to the Dealer's License & Regulations Office.
