This matter is scheduled for review based on lack of opportunity provided by the Parole Board for victim impact statement as required by statute. Under Yang vs. State, where the Parole Board has not given its final approval for parole (i.e. by a signed, sealed and delivered permit), the Board retains its authority to consider additional information and reconsider an earlier vote to grant parole.

Based on impact statements received, after hearing again from Mr. Torres and after further deliberation the Board votes to rescind Mr. Torres' previous grant of parole.

The reason for the rescission is due to the serious nature of Mr. Torres' offense, the life long injuries to the victim which include the complete loss of sight as well as the callousness and gravity of the crime. Mr. Torres received a thirty year sentence, he has been incarcerated since 2000. The Board feels that to parole Mr. Torres now would promote disrespect for the law. We will reconsider him again in two years (5/2018). Chairperson Pisaturo
