Pharmacy Regulations/Review: Cathy Cordy distributed compounding material for Board Members for review. Jonathan Mundy addressed the Board regarding OTC products. Charles Alexandre addressed the Board regarding licensure renewals for Technicians. Fees will be raised. Community Review scheduled for March 5th at 11:00 a.m.

ACS Proposed Amendments to CSA: Material distributed to Board Members for review. Recommendations for amended language from ACS include removal of quantity limitations for scheduled drugs. Board expressed concern about this change and requested that ACS provide complaint information and language from other states for review.

PMP Update/Compliance/Conference: Cathy Cordy addressed the Board. Data needs to be shared across the states. Federal money needed for conferences – month of June. Solid data is available for last 2 years. Individuals putting data in on a monthly basis. Able to monitor individual patients.

Adult Flu Vaccine Program: RIDOH will now provide flu vaccine for adults at no charge and by drop-shipment to authorized individuals.

Board requested that preservative-free vaccine be available for pregnant women.
