**Meeting was called to order at 9:14 am by Michael St. Martin.**

**A motion to accept the minutes from the last meeting was made by Anthony Cardarelli and seconded by Vincent Walsh. Passed unanimously by the board.**

**Hearing:**

**Craig Zottoli, The Irrigation Company –two violations, one from June 15, 2007 #3223**

**Craig Zottoli and Pat Luther are sworn in. Mr. Luther reads the violation.**

**On or about June 1, 2007, E. Patrick Luther, Chief Plumbing Investigator, witnessed Barry Mikels, 379 West Royalston Road, Apt, J3, Athol, Massachusetts 01331-9328: Michael R. Martin, 24 Main Street, Hubbardston, Massachusetts 01452-1440: and Thomas Bruce, 132 Elizabeth Street, Athol, Massachusetts 01331-9328, installing underground lawn sprinklers at CVS, Route 44, Chepachet, RI. Mr. Mikels, Mr. Martin and Mr. Bruce are not licensed in Rhode Island to do this work. This is one violation of RIGL 5-20-9-“practices for which a master’s license is required”. The Irrigation Company, P O Box 415, Princeton, Massachusetts 01541 does not have a licensed individual within its corporate structure. This is a violation of RIGL 5-20-12-“corporations and firms engaged in business”. There was no permit taken out with the Town of Glocester for the installation. This is a violation of RIGK 5-20-26-“municipal inspectors and installation permits” Three violations at \$500.00 for a total of \$1500.00.**

**A second violation against Craig Zottoli, The Irrigation company-#3539-**

**Pat Luther reads the violation.**

**On September 4, 2008 The Irrigation Company, Craig Zottoli did have Barry Mikels, 379 West Royalston Road, Apt. J3, Athol, MA 01331-+328, and Jarrod W. Girardin, 58 Kendall Road, Holden, MA 01520-1201 at the CVS, 2250 New London Turnpike, Coventry, RI installing underground laws sprinklers, neither of these individuals were licensed in Rhode Island and the Irrigation Company does not have a licensed individual within its corporate structure. There are two (2) violations of RIGL 5-20-9-“acts for which a journeyperson license required”, and one violation of 5-20-12-“corporations and firms engaged in business” for a total of \$2850.00.**

**The board questioned Mr. Zottoli on both violations.**

**The board questioned Mr. Luther on both violations.**

**Michael Newman made a motion that violation #3223 did occur seconded by Vincent Walsh, passed unanimously by the board.**

**Michael Newman made a motion to uphold the fine of \$1500.00 seconded by Vincent Walsh, passed unanimously by the board.**

**Michael Newman made a motion that violation #3439 did occur seconded by William Riley, passed unanimously by the board.**

**Michael Newman made a motion to reduce the fine of \$2850.00 to \$1500.00 seconded by Anthony Carderelli, passed unanimously by the board.**

**Approval of apprentice registrations, a motion to accept the apprentice registrations was made by William Riley and seconded by Michael Newman. Passed unanimously by the board.**

**Under the enforcement section of RIGL 5-20-33.1, board members have the right to go n a job site and ask to see a license.**

**A motion to adjourn was made by Vincent Walsh and seconded by Anthony Carderelli.**

**The meeting adjourned at 9:40 am.**
