

**BRISTOL WARREN REGIONAL
SCHOOL COMMITTEE MEETING**

Monday, May 11, 2015

The bi-monthly meeting of the Bristol Warren Regional School Committee was held on Monday, May 11, 2015, in the cafeteria of Mt. Hope High School, 199 Chestnut Street in Bristol, RI. The Chairperson, John Bento, called the meeting to order at approximately 7:07 PM.

ACCOLADES

AGENDA FOCUS

COZ PRESENTATION

Patricia Brissette, Coordinator, Bristol Warren Family Resource Center - A Child Opportunity Zone (COZ) program, thanked the School Committee for inviting the Bristol Warren Family Resource Center to present this evening. Ms. Brissette personally thanked the Superintendent, Assistant Superintendent and Administrators for their support of the Bristol Warren Family Resource Center.

Ms. Brissette also extended a thank you to The Reverend Lucey and St. Michael's Congregation for their generous gift to the Bristol Warren Family Resource Center. She shared how the donations will be used for programs within the Bristol Warren Family Resource Center.

Ms. Brissette introduced, Emily Pearce-Spence, Program Manager for Bristol Warren Family Resource Center's Parents As Teachers (PAT) program which is an international home visiting program.

Ms. Pearce-Spence shared the history of the Parents As Teachers (PAT) program from its inception in Missouri 30 years ago to its

active history in Bristol and Warren for the past 21 years. Ms. Pearce-Spence described the many benefits offered to families through the Parents As Teachers (PAT) program.

Molly Marston, Michelle Katafiasz and Nicky Piper shared personal testimonies, from a parent's perspective, regarding their excellent experiences with the Parents as Teachers Program.

Kristine Campagna, Chief Program Development of Early Childhood Newborn Screening and Follow-Up Programs, Department of Health, shared about the Department of Health's collaborative work with the Bristol Warren Family Resource Center, the School Department, RIDE and parents within the community. Ms. Campagna emphasized the importance of early childhood experiences and school readiness commending the Parents As Teachers program for focusing on those needs.

Ms. Pearce-Spence closed by sharing the key components of the Parents As Teachers Program which lead to school readiness for the child.

Ms. Pearce-Spence introduced the Thrive by Five and Beyond Program which she cofounded with Donna Ramos-Razza. The group was modeled after Newport's Thrive by Five Group. The group is comprised of representatives from Bradley Hospital, DCYF, the Women's Resource Center and the Bristol and Warren Substance

Abuse Task Force. The Thrive by Five and Beyond group meets monthly to share information from their individual fields and program offerings to strengthen support to the families.

Ms. Leslie Anderson, Director of Pupil Personnel Services, shared the goals, mission and accomplishments of the East Bay Thrive by Five & Beyond program.

Ms. Brissette introduced Elizabeth Brito, Executive Director, Rhode Island Association for Supervision and Curriculum Development (RIASCD) & the Whole Child Initiative.

Ms. Brito thanked the Superintendent and Administrative team for the invitation to share about Rhode Island Association for Supervision and Curriculum Development (RIASCD) & the Whole Child Initiative.

Ms. Brito explained RIASCD's mission, goals and programs.

Ms. Brito introduced Ms. Rosemary Reilly Chammat, Ed. D, Chairwoman, RIASCD Whole Child Steering Committee.

Ms. Reilly Chammat expanded upon the following points of the Whole Child Initiative:

- the five tenets of the Whole Child Initiative**
- the importance and benefits of the Whole Child Approach**

- **growing support for RIASCD's Whole Child Initiative by the RI General Assembly**
- **Whole Child Initiative in action**
- **Whole Child Initiative – next steps**
- **School Committee adoption of Whole Child Resolution**
- **School Committee application for Whole Child Recognition Award**

Ms. Brissette thanked the School Committee and Administrators for their support and for the opportunities afforded to the Bristol Warren Family Resource Center.

Dr. Andrade thanked Ms. Brissette for her leadership and for the continuous improvement shown through the Bristol Warren Family Resource Center programs.

Dr. Andrade emphasized the importance of recognizing that the Bristol Warren Family Resource Center services over 500 students annually and is a totally self-sufficient program. The programs of the Bristol Warren Family Resource Center are provided at no cost to the taxpayers of Bristol and Warren. Dr. Andrade thanked Ms. Brissette for her excellent fiscal planning.

Mrs. Wainwright mentioned that the National School Board Association is going to be hosting a luncheon conference in Boston at which time an award for outstanding learning opportunities will be presented. Mrs. Wainwright stated that the East Bay Thrive By Five &

Beyond Program will be submitted for this award. She added that there will be cash prizes associated with the award. Mrs. Wainwright thanked Ms. Brissette and her employees for all that they do.

Mr. O'Dell asked for clarification on what benchmarks a school would possess when practicing a whole child approach.

Ms. Reilly Chammat responded that the whole child approach is part of the framework currently being practiced within the District to support children and their families. Dr. Andrade added that the Bristol Warren Regional School District Administrators have been engaged in the Whole Child conversation for over ten years and are participating members in ASCD. Dr. Andrade stated that the philosophy has been in place within the District, but it wasn't referred to as "Whole Child". The District, however, has delivered the same message of the Whole Child Initiative. Dr. Andrade reiterated that the Whole Child Initiative is not new to the District, but just a clearer way to communicate to the community that the District supports the whole child.

Mr. O'Dell asked what the confidence level is that the entire community is aware of the programs offered by the Bristol Warren Family Resource Center. He shared about a program that the Post Office offers, where fliers can be dispersed to an entire community.

Chairman Bento thanked all those who presented this evening to

share about the beneficial programs of the Bristol Warren Family Resource Center. He thanked Ms. Brissette for her vision and dedication, and thanked the parents for their testimonials.

Chairman Bento stated that the School Committee will be looking to add the Whole Child Resolution as an agenda item for a future meeting.

Several School Committee members shared personal testimonies to further stress their support for approving the School Committee

Resolution on Gun Free Schools.

Mr. O'Dell stated that he agrees with the Resolution on Gun Free Schools conceptually, but had a few questions related to item #5 and #9 of the resolution. Mr. Belair clarified those points for Mr. O'Dell.

The motion passed unanimously.

The School Committee Goals discussion will be revisited in August to allow for further clarification of the requested changes made this evening.

The motion passed with a 4-1 vote; Mr. O'Dell dissenting.
