**Motion to approve the following Proclamation of Emergency/Disaster and authorize the Town Council President to sign:**

### TOWN OF CHARLESTOWN, RHODE ISLAND PROCLAMATION OF EMERGENCY/DISASTER

**WHEREAS**, the Town Council of the Town of Charlestown does hereby find; that conditions of extreme peril to the safety of persons and property will arise within said town as of 11:00 p.m. on the 12<sup>th</sup> day of March, 2018 and;

That these conditions are or are likely to be beyond the control of the services, personnel, equipment and facilities of said Town, and;

**NOW, THEREFORE, IT IS HEREBY PROCLAIMED** that a local emergency now exists throughout said Town and;

**IT IS FURTHER PROCLAIMED AND ORDERED** that during the existence of said local emergency the powers, functions and duties of the emergency organization of this Town shall be those prescribed by state law, by ordinances, and resolutions of this Town, and;

That this emergency proclamation shall expire in 7 days after issuance unless confirmed and ratified by the governing body of the Town of Charlestown.
