

**TOWN OF BARRINGTON
HARBOR COMMISSION MEETING MINUTES
Wednesday May 8, 2013**

Brian Hunt called to order 7:30 pm.

1) Approval of Minutes of April 10th

- Motion was made by Paul Dennis to accept the minutes of the April 10, 2013 meeting; seconded by Chip Hawkins.
- Motion passed unanimously by Brian Hunt, James Forster, Jay Dwyer, Paul Dennis, Ed Schottland, Anne Chapin. Chip Hawkins abstained due to his absence from the meeting. Mike Reuter was not present at the time of the vote.

2) Harbormaster's Report:

- Patrols will start on May 18th
- Police Cove may soon have to have a waiting list for moorings
- Two moorings currently infringing on the channel will be moved next week. A third mooring will be moved later
- Nun 4 and Nun 2 have been moved to straighten out the channel
- 2 markers will be purchased to be located north of the floating dock
- Ray has contacted DOT to put day markers on the bridge eliminating the need for markers further up the channel.
- Ray had a conversation with the Warren Harbormaster (Matt Colaro) about moving 3 moorings in the Warren River between Can 1 and Can 23. After much discussion Matt agreed to move them.
- A discussion was had regarding fishing on the bridge. DOT is not going to post signs restricting or prohibiting fishing on the bridge.
- A kayak was reported abandoned on Rumstick Point. It was reported to have a jacket, paddle, fishing gear and life jacket in it. When police went to investigate the kayak was gone.

- Brian will represent the Harbor Commission on the Police Cove Commission.
