

Minutes of School Committee Meeting 07/09/14

A meeting of the Barrington School Committee was held on Wednesday, July 9, 2014, at the Administration Building. Mrs. Brody called the meeting to order at 7:32 a.m. Present were Mrs. Brody, Dr. Dominguez, Mr. Guida, Dr. Shea and Mr. Messore. Absent was Mr. Fuller.

New Business from Superintendent and Staff
