

A SPECIAL MEETING of the Burrillville Town Council held Wednesday, May 18, 2005 at 9:00 A.M. in the Council Chambers, Town Building, 105 Harrisville Main St., Harrisville, for and within the Town of Burrillville.

MEMBERS PRESENT: Council President Wallace F. Lees, Councilors William A. Andrews, Nancy F. Binns, Margaret L. Dudley, Ronald E. Faford and William E. Gonyea.

MEMBERS ABSENT: Councilor Jacqueline Zahn was excused due to a work commitment.

New Business:

1. VOTED to receive and open the correspondence from Clement Badeau d/b/a Village Barn, LLC, regarding his request for additional time to complete the work to comply with fire code requirements in connection with the licenses for Village Barn LLC.

Motion by Councilor William A. Andrews. Seconded by Councilor Ronald E. Faford. The motion was unanimous by the six members present. Voting in favor of the motion were Council President Wallace F. Lees, Councilors William A. Andrews, Nancy F. Binns, Margaret L. Dudley, Ronald E. Faford and William E. Gonyea. Councilor Jacqueline Zahn was excused.

Discussion: Clement Badeau of Village Barn LLC explained the electrician had been working on the fire code issues but that the work on the fire alarm system was incomplete. Mr. Badeau said that the work had been budgeted, the contract had been signed, work had begun, but that the signal alarm box was on back order. Walter J. Kane, Town Solicitor, explained the potential liability to the Town and the Town Councilors, individually, if they issued a license despite the report from the Fire Marshall. Mr. Kane suggested that the Town Council consider extending the license to June 30, 2005. There was some discussion of the problems businesses are having in completing these projects because of the changes in the fire code, resulting in a large demand on parts and labor.

VOTED that a license extension be granted to June 30, 2005.

Motion by Councilor William A. Andrews. Seconded by Councilor William E. Gonyea. The motion was unanimous by the six members present. Voting in favor of the motion were Council President Wallace F. Lees, Councilors William A. Andrews, Nancy F. Binns, Margaret L. Dudley, Ronald E. Faford and William E. Gonyea. Councilor Jacqueline Zahn was excused.

VOTED to adjourn at 9:10 A.M.
