Mr. Wolfe opened the Public Hearing at 10:00 A.M.

**Comments/Input/Recommendation by Walter Kane, Attorney for the Commission** – Mr. Kane stated that after the advertisement of the proposed changes to the Rules and Regulations the Engineer representing LaGinestra had two areas of concerns which the Commission's Engineer, Mr. Geremia, addressed. The Commission has been provided a copy of the Rules and Regulations with the changes that address LaGinestra's concerns. Mr. Kane advised the Commission to adopt these changes to the Rules and Regulations.

**Comments/Input/Recommendation from the Superintendent/Engineer** – Mr. Martin stated that he had reviewed the changes to the Rules and Regulations and they appear to fit within the capability of the sewer treatment plant.  
Mr. Geremia reviewed the changes that were made to the Rules and Regulations based on the questions from LaGinestra's Engineer.

**Comments from the Public** – Mr. Wood thanked the Commission for being proactive in working with LaGinestra on these proposed changes.

**Comments/Input/Recommendation from the Commission** - None

**Consider and take action on proposed changes to the Rules and Regulations Governing the Public Sanitary Sewer System in the Town of Burrillville** – Mr. Andrews made a motion to include the modifications made by Mr. Geremia to the Rules and Regulations. The motion was seconded by Ms. Smith.

Mr. Peterson made a motion to adopt the proposed changes and amendments to the Rules and Regulations effective January 1, 2012. The motion was seconded by Ms. Smith.

Mr. Peterson made a motion to adopt Exhibit A with a surcharge fee of \$0.83 for BOD and \$0.60 for TSS and a monitoring fee of \$1200.00. The motion was seconded by Mr. Andrews.

Mr. St. Pierre thanked the Commission for working with LaGinestra on this matter.

Being no further business to come before the Commission, Mr. Peterson made a motion to adjourn. The motion was seconded by Mr. Andrews.
