## **Minutes**

**1) Call to Order-The April 5th meeting of the Tiverton School Committee was called to order by Mrs. Black at 7:00 p.m.**

### **2) Old Business**

**a) 2011/2012 Budget-Since the last meeting there have been some changes in the budget requests. Following discussion regarding the budget the following motions were made:**

- A motion was made by Coulter/Pallasch to approve 3/5th's Reading position at Ranger School. Vote 5-0.**
- A motion was made by Coulter/ to purchase a district-wide assessment. Hearing no second the motion failed.**
- A motion was made by Coulter/Black to approve a 2/5th's position at the high school. Vote 5-0.**

- A motion was made by Pallasch/Herrmann to create a new 2/5th's position at the middle school. Vote 4 in favor, 1 opposed (Coulter).
- A motion was made by Pallsach/Black to approve the late busses at the middle school. Vote 5-0.
- A motion was made by Pallasch/Black to approve two servers. Vote 5-0.
- A motion was made by Pallasch/Herrmann to approve repairs to the electrical system at the high school. Vote 4 in favor, 1 opposed (Coulter).
- A motion was made by Pallasch/Black to approve increasing the 4/5th's music position at the middle school to full-time. Vote 5-0.
- A motion was made by Pallasch/Herrmann to approve a budget of \$26,936,506. Vote 5-0.

### **3) New Business**

- a) Discussion on Development of School Committee Proposal for Financial Town Meeting Docket-W. Rearick-Discussion only, no action was taken.
- b) RIASC Meeting-Unified Chart of Accounts/State Report-Mr. Rearick made a brief comment about the district's per pupil cost. This item will be discussed at the next meeting.
