Item No. 2

There were no public comments.

Item No. 3

Motion by Stephen C. Waluk, seconded by Arthur H. Fletcher, passed unanimously to approve the minutes of March 10, 2010 meeting.

Item No. 4

Motion by Stephen C. Waluk, seconded by Arthur H. Fletcher, passed unanimously to approve:

Item No. 5

Buddy Croft and Chairman David A. Darlington discussed their meeting in Washington DC with the Rhode Island delegation on the Authority's appropriations request of \$50,000,000 for Steel and Painting, \$750,000 for additional Security Camera's on both Bridges, and for \$921,000 for the construction of an Emergency Command Center. Buddy stated that the Authority will continue to apply and pursue vigorously funding issues for the RITBA.

Item No. 6

Buddy Croft discussed the RITBA Bond sale and its success. Chairman David A. Darlington reported that RITBA received approximately 44 million in usable proceeds for R&R Projects. This was a very lengthy process that went very well for the Authority.

Item No. 7

Motion by Stephen C. Waluk, seconded by Arthur H. Fletcher, passed unanimously to approve in the form of a Resolution Pannone Lopes Devereaux & West LLC Contract extension for two (2) additional one (1) year periods upon the same terms and conditions as contained in the Contract. Stephen C. Waluk noted that the billable rate per hour would also stay the same.

Item No. 8

Motion by Stephen C. Waluk, seconded by Arthur H. Fletcher, passed unanimously to approve in the form of a Resolution Lefkowitz, Garfinkel, Champi & DeRienzo, P.C. be awarded the RITBA Audit Contract for 2010, 2011 and 2012 in amount not to exceed \$49,500.00.

Buddy Croft and Chairman David A. Darlington reported on discussions with the Auditor General's office as well as the Rhode Island Department of Administration and their position was that we

go select the lowest qualified bidder and not to rebid the Contract.

Stephen C. Waluk requested it be noted in the minutes that he thought it was wrong the RITBA was being required by the Auditor General to award the Contract to the qualified low bidder despite the Authority's objection.

Item No. 9

Motion by Stephen C. Waluk, seconded by Arthur H. Fletcher, passed unanimously to approve in the form of a Resolution the Authority's game sponsorship of the Newport Gulls for the 2010 season in the amount of \$2,500.00.

Buddy Croft related to the Board that the Newport Gull's meet the criteria on what the Authority looks for in a sponsorship.

Item No. 10

Motion by Stephen C. Waluk, seconded by Arthur H. Fletcher, passed unanimously in the form of a Resolution to approve the Authority to issue a request for proposals to solicit proposals from companies to salvage and scrap the Authority's surplus tokens.

Stephen C. Waluk amended the termination for the Authority's token redemption program to May 15, 2010 at 2:00 P.M. instead of April 30, 2010 at 6:00 P.M. as stated in the Resolution.

Buddy Croft reported that the Authority has approximately 5000

pounds of brass salvage and the “going rate” was \$1.75 per pound. The Authority has received numerous requests from private vendors for resale of RITBA tokens and would sell tokens to private vendors for the same price per pound.

Item No. 11

Buddy Croft discussed unpaid toll legislation and a draft bill he would like the RITBA to file. The Authority is experiencing 1,000 unpaid tolls per month of which many are repeat offenders.

He reported that 15 certified letters were sent out to offenders with repeated unpaid fees and that the Authority will listen and work with the general public on any unforeseen circumstances regarding payment to the Authority.

The draft bill called for four (4) categories for nonpayment of toll. After discussion with the Board it was decided to have three (3) categories in which to respond. The first violation being you will have 30 days for toll payment. The second violation is to pay the toll plus a fifty dollar (\$50) fine. The third violation, RI General Laws Chapter 12 of Title 24 under subsections (a) (2) and (a) (3) shall receive a traffic violation summons which shall be subject to the jurisdiction of the traffic tribunal and pay the toll and \$100.00.
