Brayton, passed unanimously to enact increase on the Sakonnet River Bridge to a \$.50 toll and non-E-ZPass customer's \$3.75. starting May 16, 2014 as reflective in the Jacobs report. No driver would have to pay for more than two trips per calendar day. As a backup plan, Motion (No.2) by Deborah M. Brayton, seconded by Michael P. Lewis, to increase Newport/Pell Bridge toll from \$.83 to

\$1.04 for RI E-ZPass customers and \$4.00 to \$5.00 for cash or out of state E-ZPass customers. Vice Chairman Stephen C. Waluk opposed.
