II. Superintendent's Report

- c. Lincoln High School Student Update  
Principal McNamara introduced Bennett Allen, Student Council President. Bennett said he has been on Student Council for three years and is looking forward to next year. He is looking to make Spirit Week run smoothly. He plans to work with the younger classmen and hopes they can look up to him as a positive role model.
- d. NECAP Update Presentation  
Superintendent Fortunato and Director of Curriculum Frey reported on the 2012-2013 and 2013-2014 initiatives for NECAP readiness. Frey noted the district has worked on common core standards for the last several years and there has been professional development. This is the first year for on line Envisions Math. Next year formative assessment and interim assessment will be different. The Superintendent commended the administration that every evaluation was calibrated. She noted RIDE included the union leadership in this. She stated she was proud that all the principals passed their evaluation assessments. There will be training in August in Middletown. Fortunato complimented the teacher induction program and Caroline on her preparing readiness for PARCC. They will be holding forums and attending PTA meetings. The Superintendent suggested watching New York as they are piloting PARCC. Frey reported the focus in the fall will be preparedness for the third graders. The Superintendent reported parent outreach is critical and letters will be going home to parents on expectations for summer work. Next year, students will meet for 50 minutes with a specific teacher and the middle school is working on consistency. Improving parent engagement is so important from elementary to high school. Mr. McNamara has created a summer program for high school students with bus pickup, taking students to RIC and college students will help. Superintendent Fortunato reported she, Caroline Frey and Maryann Struble visited the Compass School to see what they were doing. There are 162 students K-8. Their school day is 8:40AM - 3:00PM. There is no union, a low incidence of special education students and high parent involvement.

Lori Miller reported the FDA is requiring they not use their free reimbursement to subsidize their prices. To be equitable, the price should increase by thirty-three cents, but there is a ten cent cap. She recommended the prices of \$2.20 and \$2.45 for lunch.

j. Financial Report/Charter Schools Update

Lori Miller reported a \$352,000 positive variance mostly coming from increasing revenue from RIDE. She is waiting for the report tomorrow for medical projections due to the trending. Special Education is over expended. RIDE housing regulations have changed. They asked for a waiver and they were told there is no waiver procedure. If they want to get housing aid, they will have to go forward with the process. They have to finish Stage 1 and then Stage 2 will be the projects the Financial Town Meeting approved. The issue Miller has is that they now have to pay an architectural firm to draft all their specifications and sign off on the work. The fees this year alone will be approximately \$122,000. She will be recommending a transfer of some money from the operating fund to the Capital Fund to cover some of this. She and Mr. Mencucci are concerned they may not have enough funding for the roof at Northern. Mary Anne Roll asked if RIDE would work with them on that. The Chairwoman read the letter sent to RIDE.
