MINUTES

At 7:00 p.m., the Board of Public Safety opened its Regular Fire session for Tuesday, February 27, 2018. Present were Assistant Chief Edward Hannon, Assistant Chief Marcel Fontenault, Chairwoman Leslie Walaska Baxter, Vice Chairman James Paolucci, Clerk Thomas McGovern, Assistant Solicitor Joseph Solomon, Jr., and Recording Secretary Lisa Ferolito.

1. Assistant Chief Edward Hannon submitted a retirement request from Lieutenant William A. Lloyd, effective March 4, 2018 at 50.0055 percent under Pension II as specified under the current Collective Bargaining Agreement dated July 1, 2015 to June 30, 2018. Lieutenant Lloyd was appointed to the department on March 3, 1997.

ACTION: Chairwoman Baxter made a motion to approve. Vice Chairman Paolucci seconded the motion. Chairwoman Baxter, Vice Chairman Paolucci, and Clerk McGovern voted in favor of the motion. Motion approved.

Superintendent Moan was appointed to the department on March 20, 1988.

ACTION: Chairwoman Baxter made a motion to approve. Vice Chairman Paolucci seconded the motion. Chairwoman Baxter, Vice Chairman Paolucci, and Clerk McGovern voted in favor of the motion. Motion approved.
