The Johnston Town Council held a Special Meeting on **Monday, September 24th, 2018** at the Johnston Municipal Court, 1600 Atwood Avenue, Johnston, RI 02919

Council Vice-President Santilli called the meeting to order at 6:35 pm

All Councilmembers were present except for Council President Verardo

Solicitor Conley addressed the Council and noted that both sides have stipulated to have the air quality report, noise report and transcript from the September 10th, 2018 meeting incorporated into this evening's proceedings.

Council Vice President Santilli asked if anyone from the public wished to speak
No person from the public spoke about the issue

Jeff Sotek of Wood engineering briefly spoke about the air quality and noise reports

Ken Marandola of SIMS spoke about the allocation of funds to complete the sound barrier wall on the South-East side of the property

Councilman Russo made a motion to remove the conditional restrictions placed by the Council on SIMS Metal Management and to dismiss the Show-Cause hearing and that all remedial actions taken by SIMS shall remain in place

The motion was seconded by Councilman Civetti

Motion carried; Vote 4-0

Councilman Civetti requested reaching out to RI DOT to have the expansion joint on the overpass to the industrial park checked and to speak with the Town's Representatives and Senators regarding having a sound barrier installed on the section of Rt. 295 closer to the resident's side

Short discussion ensued

Adjournment

Councilman Russo made a motion to adjourn
The motion was seconded by Councilman Civetti
Motion carried; Vote 5-0

The meeting adjourned at 6:52 pm
