APPOINTMENT OF PROBATE JUDGE

MOTION by Mrs. Charest, seconded by Ms. Alves, and voted unanimously on a roll call vote to appoint Howard Portney as Probate Judge. This is a two-year term that will expire December 1, 2012.

APPOINTMENT OF MUNICIPAL COURT JUDGE

MOTION by Mrs. Charest, seconded by Ms. Alves, and voted unanimously on a roll call vote to appoint Aram P. Jarret, Jr. as Municipal Court Judge. This is a two-year term that will expire December 1, 2012.
