The 71st Annual meeting of the Bradford Fire District was held on Sept 12, 2006 at the Bradford Citizens Club. The meeting opened by Moderator Frances Killeen at 7pm with 21 voters present.

The minutes of the last meeting were read and accepted on a motion by Jay Sullivan and 2nd by Virginia Abruzzese.

The Tax Collector report was read and accepted by a motion made by Jay Sullivan and 2nd by Virginia Abruzzese.

The Board of Engineers report was read and accepted on a motion made by Ralph Abruzzese and 2nd by Billy Briggs.

The Tax Assessors report read and accepted on a motion by Elain Harris and 2nd by Billy Briggs.

The Auditors report was read and accepted with a motion made by Brenda Laspee and 2nd by Brian Marreson.

The budget of \$105,943 was accepted on a motion made by Michael Denniger and 2nd by Donald Ellis.

The Truck committee asked Peter Harris to look at the 1980 truck because the truck is in very bad condition and needs to be replaced. Brian Morrison of the truck committee said that a new truck would cost around \$312,000. A motion was made and 2nd that a new fire truck be purchased for \$312,000 and that \$12,000 be used from surplus. Then \$300,000 be borrowed best interest rate available with the moderator is to sign the Promissory note and other documents as required to purchase the truck. The Chief is authorized to sign for a new truck at a price no more than \$312,000.

Motion made and 2nd to sell the 1980 truck for best price.

A moment of silence was observed in memory of Robert Sullivan and Ray Laspee who passed away this year.

The building committee had not met, but the fire district land was perc tested. The committee will let us hear later how this is going.
