1 **(HEARING COMMENCED AT 7:30 P.M.)**

2 **MR. ROTELLA: May I have a motion**

3 **to approve the agenda?**

4 **MR. COSTA: So moved.**

5 **MRS. CROWLEY: Second.**

6 **MR. ROTELLA: Motion by Mr. Costa,**

7 **second by Mrs. Crowley. All those in favor,**

8 **opposed? The ayes have it. The next order of**

9 **business is the swearing in of new members. We**
10 **have the mayor of the town, Mayor McKee here**
11 **this evening to administer that oath of office.**
12 **I would ask everybody to rise.**

13 **MR. MCKEE: Well, thank you, very**
14 **much, and it's a pleasure to be here tonight to**
15 **swear in the school committees and elected**
16 **officials in the Town of Cumberland, they all**
17 **carry a great deal of responsibility, and I'm**
18 **sure that this committee is going to do a great**
19 **job living up to that responsibility of working**
20 **on behalf of our community and also on behalf of**
21 **the young people that attend our schools.**

22 So I'm happy to be here, and if you

23 could raise your right hand and repeat after me

24 and just fill in your name:

10 MS. MORELLE: I'd like to thank you

11 for joining us this evening, and I'd also like

12 to extend on behalf of the administration our

13 congratulations, and welcome the Cumberland

14 School Committee for the 2008-2010 term. We all

15 look forward to working with you in

16 accomplishing the goals of the Strategic Plan,

17 and we expect the next two years to be a very

18 productive and very exciting time for the

19 Cumberland Public Schools.

7 MR. WOOD: Second.

8 MR. ROTELLA: Motion was made by

10 **going to take care of the balance of the**
11 **election, or would you like me to do it?**

12 **MR. CHAIRMAN: I'll handle it from**
13 **here. Next we have is the vice chair.**

14 **MR. KELLY: Mr. Rotella, that was a**
15 **motion to close the nominations, not for the**

16 vote for the chair.

17 MR. ROTELLA: No, that was a vote

18 to close the nominations for the chairperson,

19 and he did.

20 MR. KELLY: No, no. He voted to

21 close the nominations. That was the vote.

22 MR. ROTELLA: It was a 6 to 1 vote

23 to close nominations, and then we went through a

3 MR. PEARSON: Yes.

4 MS. BEAULIEU: No.

9 MR. CHAIRMAN: The chair votes yes,

10 5 to 2. Congratulations, Mr. Pearson.

11 MR. COSTA: The next item on the

12 agenda is the Appointments and

13 Subcommittees/School Liaisons. I would like to

14 have Mr. Pearson, as clerk, read off the

15 appointments to subcommittees and school

16 liaisons.

17 MR. PEARSON: Thank you, Mr.

18 Chairman. The following appointments for

19 2008-2010 sub-committees. For the finance

20 sub-committees, Chairperson, Brian Kelly;

21 members, Brian Pearson, Lisa Beaulieu. For the

22 Personnel Subcommittee, Brian Pearson,

23 Chairperson; members, Earl Wood and Brian Kelly.

24 For the Curriculum Subcommittee, Chairperson

25 Lisa Beaulieu; members, Rosa Crowley and Earl

1 Wood. For the Facilities and Technologies

2 Sub-Committees, Chairperson, Earl Wood; members,

3 Brian Pearson and Dan Pedro. For the

4 Alternative Resource Committee, Rosa Crowley,

5 members, Lisa Beaulieu and Dan Pedro. For the

6 Rules and Regulations SubCommittees,

7 Chairperson, Dan Pedro, members, Brian Kelly and

21 **MS. MORELLE:** And could you repeat
22 **the liaison to North Cumberland Middle School?**

23 **MR. PEARSON:** Earl Wood and Brian
24 **Kelly.**

25 **MS. MORELLE:** Also, just a

1 **question. Are you making appointments to the**
2 **liaisons for the Cumberland Special Education**
3 **Advisory Counsel at this time, or the Woonsocket**
4 **Career and Technical Center?**

5 **MR. CHAIRMAN:** I know about the

6 liaison for the Advisory, the special ed, but I
7 totally forgot about the Woonsocket Technical.
8 We could have, if she wouldn't mind, Rosa
9 Crowley, I believe she was the liaison to the
10 Woonsocket Technical a few years back. Would
11 you mind taking Woonsocket Technical?

12 MS. CROWLEY: I don't mind.

13 MS. MORELLE: Thank you, Mr. Costa.

14 MR. COSTA: And as far as the
15 Special Ed Advisory Committee, any volunteers,
16 anybody wishes to -- they meet the first
17 Wednesday of every month at the Cumberland
18 Library. Okay. Lisa Beaulieu as the Cumberland

19 **Special Ed Advisory Committee. Dr. Morelle,**
20 **that concludes the Cumberland Town Council. I'd**
21 **like to put a hold on that for the time being,**
22 **okay?**

23 **MS. MORELLE: That's fine. May I**
24 **ask, could you clarify the names of the**
25 **sub-committees.**

1 **MR. CHAIRMAN: We have a list.**

2 **MS. MORELLE: Thank you.**

3 **MR. CHAIRMAN: I believe that**

4 covers the sub-committees and school liaisons,
5 Dr. Morelle, with the exception of the Town

7 MS. MORELLE: Are we substituting
8 Facilities and Technologies sub-committees for
9 Properties Sub-Committees?

10 MR. ROTELLA: There's nothing on
11 the agenda that constitutes to do that.

12 MR. CHAIRMAN: Dr. Morelle, just
13 put it under properties, like we had before, for
14 the time being.

15 MS. MORELLE: And was the other one
16 that I heard mentioned, Alternative Resources?

17 **The standing committee before was Special**
18 **Programs, so that's Special Programs?**

19 **MR. CHAIRMAN: Yes.**

20 **MS. MORELLE: I think that I have**
21 **all the information. Thank you.**

22 **MR. CHAIRMAN: Thank you, Dr.**
23 **Morelle. Next item on the agenda is Home School**
24 **Instruction Request of 2008/2009 school year.**
25 **Dr. Carney?**

1 **MS. CARNEY: Yes, you have two new**

2 requests in front of you this evening. We
3 looked at the programs that are to be followed
4 and we recommend that you approve.

5 MR. PEARSON: So moved.

6 MR. CHAIRMAN: Motion by Mr.
7 Pearson to approve the Home School Instruction
8 Request for the 2008/2009 school year.

9 **none. All in favor, against?**

10 **MR. KELLY: No.**

11 **MR. CHAIRMAN: 6 to 1. Next item**

12 **on the agenda is the Approval of Executive**

13 Session of 10/9/08.

14 MRS. BEAULIEU: So moved.

15 MR. CHAIRMAN: Mr. Wood?

16 MR. WOOD: We didn't see those.

17 MR. CHAIRMAN: Okay.

18 MR. WOOD: Motion to table?

19 MR. PEARSON: Second.

20 MR. CHAIRMAN: All in favor,

21 against?

22 MS. BEAULIEU: No.

23 MR. CHAIRMAN: 6 to 1 to table the

24 Executive Sessions of 10/09/08.

25 The next is the comments from the

1 public. Mr. Rotella, do we have any comments
2 from the public, do we have a list? We see one
3 gentleman up there waving his finger. Is that
4 Mr. McLaughlin?

5 MR. MCLAUGHLIN: Ladies and
6 gentlemen, I'd like to congratulate you, God
7 bless and good luck. For the former members of
8 the school committee, I'd like to thank them for
9 their time and service. The first thing I
10 wanted to say tonight is Sunday night we'll be

11 hosting a meatball and spaghetti dinner. St.
12 Thomas Knights of Columbus. It will be from 5
13 to 8, tickets are \$10, and like to see you show
14 your support.

15 Also, December 20th we'll be
16 hosting a Christmas of giving. In this tight
17 economy, there's a lot of people hurting in the
18 Town of Cumberland, and we're going to do our
19 best to get something started to help them
20 financially. So with that said, good luck all
21 of you, God bless and keep the bickering to a
22 minimum. Thank you.

23 MR. CHAIRMAN: Thank you, Mr.

24 McLaughlin. Mr. Richard Otto?

25 MR. OTTO: I'd like to ask if you

15

1 can restart the process of videoing the school

2 committee meeting. I miss that. I do see we

3 have a stenographer, and I know they're

4 expensive. I don't know if the videography is

5 less expensive. You might want to consider that

6 in our budget.

7 MR. CHAIRMAN: Thank you, Mr. Otto.

8 MS. BEAULIEU: We're working with

9 the network manager from the Town Council to
10 bring the similar video feed that the council
11 has, so you'll be able to access it from the, I
12 don't know whether it would be the town's
13 website or the school website, but it will be in
14 the similar feed that will be available.

15 MR. CHAIRMAN: Mr. Higgins.

16 MR. HIGGINS: Mr. James Higgins?

17 MR. ROTELLA: Mr. Chairman, one

18 other thing. The meeting is being videotaped,

19 and it's being videotaped from our booth.

20 MR. CHAIRMAN: Thank you, Mr.

21 Rotella.

22 MR. HIGGINS: Ladies and gentlemen

23 congratulations on your victories, and we know

24 that you all have worked hard to get where you

25 for the purpose that you are here for, and that

1 is to support children and education in

2 Cumberland. On behalf of the Town Council, some

3 of you with me tonight, Councilor Lemoy,

4 Councilor Kirkpatrick, Councilor Ashton. I know

5 Councilor Albuquerque is in the back. Councilor

6 Dwyer is also here. Councilor Morris extends

7 her apologies for not being able to be here. On
8 behalf of all of us, we look forward to working
9 with you in these tight economic times, it's
10 going to be a challenge, but we'll try to do the
11 best we can, as long as we keep up with the
12 lines of communication that we have established
13 in the last two years, I feel that it will be
14 success, so good luck.

15 MR. CHAIRMAN: Thank you, Mr.
16 Higgins. Next on the agenda is the School
17 Committee Comments. Any School Committee
18 Comments?

19 MR. WOOD: Just a reminder that

20 junior classes have their ring ceremony this
21 Monday night. The school committee is welcome,
22 6:00, I believe, here in the auditorium.

23 MR. CHAIRMAN: Mr. Kelly?

24 MR. KELLY: Just a couple of
25 points. Not that I take offense to paying the

17

1 stenographer, the stenographer earning their
2 money, but we've all seen in the paper that the
3 state's facing a \$375 million dollar budget gap
4 this year, approximately \$500 million next year.

5 I believe that the clerk of the school committee
6 should be able to ably take the minutes, and
7 this is no reflection on the current
8 stenographer here. It costs us an average of
9 \$700 a meeting, money that will be put to good
10 use elsewhere, especially with the tight budgets
11 that are coming up. No offense to the police
12 officer. I would hope that we would also
13 eliminate the need for a police officer here and
14 I would ask that those two items be placed on
15 agenda for the next meeting. Thank you.

16 MR. CHAIRMAN: Dr. Morelle, can we
17 have it for the December meeting?

18 **MS. MORELLE: I'd be happy to**
19 **discuss those items with you, and at least one**
20 **of those items might better to be discussed in**
21 **executive session, the matter of the police**
22 **officer, police detail.**

23 **MR. CHAIRMAN: Any other school**
24 **committee comments? Mrs. Beaulieu?**

25 **MRS. BEAULIEU: I would also like**

1 **to request a few items on the agenda, given our**
2 **past struggles on the committee, I'd like to see**

**3 a code of conduct established for the committee,
4 and for the committee to work together on that.**

**5 I think a dress code would be in order to offer
6 a degree of professionalism, I think the public
7 expects that from us, and I'd also like to have
8 an agreement of confidentiality established
9 between the school committee, given that there
10 seems to be some severe compromises of the
11 confidential nature of some of the executive
12 session's information. I'd like to ensure that
13 the committee is accepting of the agreement to
14 protect the privacy of what occurs in executive
15 session. And lastly, I just wanted to go on the**

16 record that I am concerned with the choice of
17 chair, given the circumstances we've had in the
18 past, and I believe my vote reflects that.

19 Thank you.

20 MR. CHAIRMAN: Thank you,
21 Mrs. Beaulieu. On the subject of code of
22 conduct and the confidentiality, I believe we
23 could put that under rules and regs. Would that
24 be okay?

25 MRS. BEAULIEU: That's fine, and I

1 **have one other thing to add. And the last**
2 **thing, there's a memorandum of agreement between**
3 **the chairperson and the school department, and I**
4 **want to ensure to have Chairman Costa make sure**
5 **that remains in effect.**

6 **MR. CHAIRMAN: I have no problem.**

7 **Any other further comments from the school**
8 **committee people?**

9 **I would like to make a few**
10 **comments. One is, I would like to thank the**
11 **committee for their support on naming me the**
12 **chair. I also have made a commitment to the**
13 **education of the children in this community,**

14 that's foremost on my mind right now, is to
15 continue, roll up our sleeves, and we have some
16 work ahead of us, and I've made a full
17 commitment to this committee, and I have made a
18 commitment in this memorandum that I will act in
19 proper manner, behavior, and professional at all
20 times and courteous and respectful. This is the
21 position of the chair. What's been done in the
22 past has been done.

23 Right now I'm concentrating on a
24 new beginning. I'm going to roll up my sleeves
25 and do the best I possibly can to move this

1 committee forward and for the main purpose of
2 the education of our children in the Cumberland
3 School District. Thank you.

4 MR. PEARSON: Mr. Chairman, I make
5 a motion to adjourn.

6 MR. PEDRO: Second.

7 MR. CHAIRMAN: All in favor,
8 against? The ayes have it, 7 to 0. Thank you.

9 (APPLAUSE)
