Report Out of Executive Session Vote(s)

On a 7–0 vote, the committee voted to resolve CTA Grievances: #14-15-08 and #14-15-09 in accordance with an agreement with the Cumberland Teachers Association that also resolved CTA Grievances #15-16-3, #15-16-4, #15-16-5, #15-16-6, #15-16-7, and ULP #6169, #6172 and #6174.
