MR. DAVIES: 9:14 A.M. We're

going to call the meeting to order. The Department of Labor and Training Professional Regulation Board on Mechanical pipe fitting.

The first thing we will go into is hearings. Mr. Whittaker, would you go ahead and read case number 3169.

MR. WHITTAKER: The date,

5-11-2007. Violation number 3169.

Name of violator is Mr. Frank Lombardo of Frank Lombardo and Sons Incorporated, 78 Narragansett Avenue, Providence, Rhode Island 02907.

Location of the violation, 970 Broad Street, Providence, Rhode Island.

Permit number 1474.

Violation, on May 2nd, 2007, Mr. Frank Lombardo, Rhode Island License Number 6165, Refrigeration Master One and Sheet Metal Master One, took out a permit to perform mechanical work for a Mr. Kiplin B. Clemetson. Of 326 O'Connor Street, 0004

Providence, Rhode Island, 02905-2927 in the city of

2 Providence.

3 This permit was for the installation of
4 heating, cooling and duct work at the above job
5 location. Mr. Clemetson contracted for this work and
6 is not an officer or director of Frank Lombardo and
7 Sons Incorporated.

8 This is one violation of Rhode Island
9 General Law 28-27 Section 4, Loss or Revocation of
10 License.

11 One violation per Rhode Island General Law
12 28-27-24, \$500.

13 The undersigned hereby attested a truth of
14 the above allegations, Charles W. Wright,
15 Investigator.

16 MR. WRIGHT: At the previous
17 hearing, we had CK Contractors in here. Now, when I
18 did, when I wrote this violation it looked like at
19 that time that Mr. Lombardo. In fact here he comes,
20 good. Mr. Lombardo, good morning.

21 With the testimony that we had at that
22 hearing, it was obvious that Mr. Lombardo was asked
23 to take out a permit for Refrigeration. He thought
24 he was going to do that job. The testimony in

2 What happened was, he took out a permit

3 because he thought he was going to do the job. CK
4 Contractors actually did all the work, which is
5 another case that we are still going forward with.

6 Mr. Lombardo does not deserve, didn't
7 deserve this violation. But, I didn't know it at
8 that time.

9 So, that's why I'm telling the board that
10 in my opinion I think that we should move to dismiss
11 this violation. And I would encourage the board to
12 do that.

13 MR. JANUARIO: Can I make a
14 motion that we dismiss violation number 3169.

15 MR. WEBSTER: Second.

16 MR. DAVIES: All those in
17 favor.
