Organic Community Garden- No report.

Butterfly Garden –Mike M. made a motion to spend \$500.00 to repair the bio-falls filtering system at the BFG. Anne seconded. Voted unanimous. Joe stated the CC should get bigger signs to state the dog rules. Mike M. made a motion to spend \$500.00 to have new signs (2-3) made for the parking lot at Chase Park. Anne seconded. Voted unanimous.

Open Space – Anne stated that she received prices from 2 printing companies for the setup and printing of the Open Space brochures. Mike M. made a motion to allow Anne to spend \$500.00 on brochure costs. Doric seconded. Voted unanimous.

Rain Garden –No report. Mike M. stated that there will be a meeting next week with Al Rinaldi.

Shady Brook Area – Mike M. made a motion to spend \$500.00 on trees and shrubs for the Shady Brook area and other possible areas in Town. Mike G. seconded. Voted unanimous.

**VIII. NEW BUSINESS:**

Anne stated that there is poor communication between the CC and the Town Council and the Town Clerks office. Anne made a motion to write a letter, and have the letter also sent to the Town Administrator and Town Clerk. Mike G. seconded. Voted unanimous.
