Meeting Minutes

September 18, 2014

1. Call to order: President Robin Skuncik Jones called the meeting to order at 4:30 p.m. in the Rotary Board Room of the Newport Public Library.

2. Amendment to the agenda:

3. Secretary's Report:

Robin Skuncik Jones reported that the new library director Anne Shepherd will start at the library on September 26, 2014.

6. Building and Grounds Report:

There was no report at this time.

7. Financial Development Committee report:

Susan McCoy reported that this year's annual event netted \$32,785 after expenses. Attendance was 195, higher than last year's 181.

8. Friends of the Library:

At the Friends last meeting, Chuck Flippo reported that the Friends voted to pay the library's annual membership to the Newport County

Chamber of Commerce.

The Friends will present the library with a check for \$25,000 at the Library's Annual Meeting.

9. Director's Report:

In addition to her report, Regina Slezak reported that the library received a donation of \$800 from the proceeds of an auction sale and \$272 from the Peoples Credit Union from a 50/50 raffle at a Newport Gulls Baseball game.

The library has several new staff members. Leslie Varrecchia is the new reference librarian and Lauren Scrima is a part time aide in the Circulation Department. Two new pages have been added to the staff: Emily Lannon and Madeleine McMillan.
