That information will be provided to the requestor by the Board Manager.

 - Board Manager, Linda Esposito, advised Board Members that the deadline for submitting the final version of the revised Rules and Regulations has been moved to September 2017. Any changes they might want to recommend may be submitted to the Board Manager.
