1. - Call to Order:

Meeting was called to order at 9:16am by Paul Feeney, Vice Chair. A

roll call was taken by Secretary, Robert Zuba, and the following members were present: Jay Bombardier Sr, G. Thomas Chabot, Paul Feeney, Laurence E. Ryan, Jr. and Robert Zuba.

2. – Minutes of December 3, 2013:

G. Thomas Chabot made a motion to accept the minutes of the December 3, 2013 meeting; seconded by Laurence E. Ryan Jr and passed unanimously by the Board.

3. - Conflict of Interest:

Mary Ellen McQueeney-Lally, DLT Legal Counsel, addressed the Board reminding the Board they are subject to the ethics code. If there is a conflict with anything that comes before the Board with board member, family member or business associate they should recuse. Legal counsel is available if necessary.

4. - Violation Appeal Hearings:

Evinox LLC – Violation #4738: Robert Gaj, Chief Licensing Examiner, is sworn in for testimony. Evinox LLC is not present. Robert Gaj confirms that Evinox LLC has been properly noticed of the hearing. The hearing proceeded. Robert Gaj reads the violation into the record.

VIOLATION: On July 24th, 2013, DLT Chief Licensing Examiner, Robert Gaj, witnessed an employee of Evinox LLC providing infrastructure cabling for a telecommunication system. The Evinox LLC employee was performing this work without possession of Rhode Island telecommunication systems technician license. This is a violation of Rhode Island General Law-Title 5, Chapter 70 (RIGL 5-70-2 Practices Prohibited - Unlicensed technician).

Evinox LLC is not in possession of a Rhode Island telecommunication system contractor license and failed to apply for a permit with the City of Warwick as required in RIGL 5-70-2 and RIGL 5-70-19d respectively. This is two violations of Rhode Island General Law-Title 5, Chapter 70.

Evinox LLC employee - Todd Rosensweig

It is noted that this matter was previously scheduled on two other occasions but did not take place due to a lack of quorum.

Robert Gaj provides testimony and enters the following into evidence: Exhibit A: 10 photographs; Exhibit B: Letter from Evinox. Testimony continued and Mr. Gaj is questioned by the Board.

G. Thomas Chabot made a motion that a violation of RIGL 5-70-2 Practices prohibited for an unlicensed technician occurred; a violation of RIGL 5-70-2 for an unlicensed contractor and a violation of RIGL 5-70-19(d) for failure to obtain a permit did occur. The motion was seconded by Robert Zuba and passed unanimously by the Board.

G. Thomas Chabot made a motion to impose the \$1,500.00 fine; seconded by Robert Zuba and passed unanimously by the Board.

The recommendation of the Board will be forwarded to the Director's office.

Jay Bombardier Sr made a motion to request more information to substantiate his contractor license and experience needed for Data and Video.
