Minutes

- 1. President Zwolenski called the meeting to order at 7:04 pm**
- 2. Members present were President Zwolenski, Dr. Shumway, Mr. Puccetti, Mr. Soares, Mr. Jühr, and Dr. Brennan. It was reported that Dr. Benoit had a family commitment.**
- 3. Ordinance Development for discussion and action**
 - a. Ground Water Protection Overlay District**
 - i. Review of the revised overlay map and revised ordinance**
 - 1. It was moved, seconded, discussed and passed unanimously to accept the North Smithfield, RI Zoning Ordinance Map: Groundwater Aquifer Protection Overlay District dated 2/14/2012 as the official map for the Town. [Soares/Brennan]**
 - 2. It was moved, seconded, discussed and passed unanimously to pass on to the Town Council the Groundwater Aquifer Protection District Ordinance revision dated 2/15/2012. [Brennan/Soares]**
 - b. Definitions of the Districts as defined by the Use Table with special emphasis on MU1 and MU2.**

i. It was moved, seconded, discussed and passed unanimously that the District uses for Districts MU1 and MU2 be accepted as noted in the ODC revision dated 02/09/2012.

c. The Soil Erosion and Sediment Control and Stormwater Pollution Prevention Plan [SWPPP]

i. It was moved and seconded and then retracted by the authors of the motion to amend the SWPPP Ordinance by eliminating the word ‘or’ in section 18.8. Plan Review, first paragraph to read as follows ...the Planning Board, or the Planning Department...and to amend section 118.8, second paragraph, by substitution as follows: ...to respond within forty-five [45] days within twenty-one [21] business days of their.... [Shumway/Brennan]

ii. It was moved, seconded, discussed and passed unanimously to amend the SWPPP Ordinance by eliminating the word ‘or’ in section 18.8. Plan Review, first paragraph to read as follows “...the Planning Board, or the Planning Department...” [Shumway/Zwolenski]

iii. It was moved seconded, discussed and failed to pass that Section 18.8 of the SWPPP Ordinance be amended by substitution as follows: “...to respond within 45 days 30 business days of their receipt...” [Shumway/Zwolenski]. The motion failed on a 4/1 vote with Dr. Shumway casting the lone affirmative vote.

iv. It was moved, seconded, discussed and passed unanimously to call a Special Meeting on March 19, 2012 at 7pm at Kendall Dean Meeting Hall in conjunction with the Town Council in order to allow dialog with the Council on the SWPPP Ordinance if appropriate. [Zwolenski/Shumway]
