Update on Funding Formula

 Kas DeCarvalho was the Met's representative to the committee.

 There are not enough state resources to fulfill needs.

 Technical Education is still suffering without adequate funding and something we need to continue to push for in the state.

 With the advent of the funding formula, the board's rigorous stewardship plan for the future-Met has helped forestall the financial inevitability of inadequate resources.

 One RI technical school is currently facing restructuring by the state because the current funding formula does not provide the resources necessary to continue to operate the program. The school can no longer afford to continue the program without intervention.

 Technical schools need the funding formula to reflect the extra costs associated with technical education. Other states, including Massachusetts, provide technical schools with a weighted 1.33% formula above the formula applied to traditional schools. The Met will continue to work for the creation of a funding formula in RI that reflects this.

 The committee's conversations centered on traditional schools and charter schools with little attention given to technical schools. The Funding Formula Committee had an impossible task; many needs from all stakeholders and few resources.

 Charles Walton and Dennis Littky suggested contacting Leo Skenyon, House Chief of Staff and Tom Mullaney and creating a reference tool that lists helpful contacts and resources to facilitate work on the funding formula in RI. (Action Item)

Ken Wagner Article

 Commissioner Wagner, in a recent newspaper article,

addressed wanting to see change in Rhode Island educational practices: high school students taking college classes, personalized education, etc. In an effort to educate the Commissioner about the Met, which piloted these things and has refined them over the past 20 years, Nancy and Dennis met with him to help him make the connection.

Discussion Regarding Status of Budget/District Issues

• End of 2nd quarter: The biggest revenue deficit is for uncollected tuition as of the 2nd quarter.

• Banking proposal document shows scenarios of breaking out monies to 3 different banks

- o Funds need to be low risk and highly liquid, perhaps laddered investments.
