Meeting called to order at 1:15 p.m. by Mrs. Algee

OPEN SESSION:

MINUTES: No previous minutes to vote on.

OLD BUSINESS: No previous Old Business.

NEW BUSINESS:

Vote on Chair: Mr. Thibodeau made a motion to nominate Mr. Gereboff for Chair. Mrs. Emery seconded the nomination. All in favor. Motion approved.

Vote on Vice Chair: Mr. Thibodeau made a motion to nominate Mr. Russo for Vice Chair. Mr. Norigian seconded the nomination. All in favor. Motion approved.

Applications for Training: Mr. Russo, being a Board member as excused himself as being a trainer for Ms. Giammarco. Mr. Thibodeau motioned to accept the removal of Mr. Russo as trainer, and notify Ms. Giammarco to forward a new trainer letter in order for her application to be considered. Mr. Norigian seconded the motion. All in favor. Motion approved.

Mr. Thibodeau motioned to accept the training application for Mr. Goneconte with Kenneth R. Norigian as trainer. Mrs. Emery seconded the nomination. All in favor. Motion approved. Approval letter to Mr. Goneconte to follow.

Applications for Testing: Mrs. Emery motioned to accept completed training log and letter from trainer. Seconded by Mr. Thibodeau. All in favor. Motion approved. Oral and written test to be scheduled for next meeting on Monday, November 2, 2015, at 2:30 p.m.

Discussion on Board's roll/responsibilities: Board recommends approval for training and examinations. Mr. Russo and Mr. Norigian to look over the written exam to make sure it is still relevant with the new law. The Board will conduct the oral examination. Ms. Precious will give the written examination. Board plans on meeting every other month, on the first Monday unless additional meetings are required. The next meeting will be held on Monday, November 2, 2015 at 2:30 p.m.

Discussion on Department's roll/responsibilities: For renewals, if there is no problems, the Department will issue. If there is a problem or issues on renewal the Department will bring to Board.
