# Meeting Minutes of Wednesday, April 12, 2017

A meeting of the Capital Center Commission (CCC) was held on Wednesday, November 9, 2016 in the 1<sup>st</sup> Floor Conference Room of the Doorley Municipal Building, 444 Westminster Street, Providence, RI 02903.

### 1. Roll Call

Call to Order: The meeting was called to order at 12:05 PM, Chairman Sherman presiding.

Chairman Sherman noted the passing of Derek Bradford and V. Duncan Johnson. He stated that the CCC will make a contribution to the Cultural Landscape Foundation for Derek Bradford and to RISD for Duncan Johnson. # 5. Chairman's Report

Chairman Sherman noted construction on Parcel 6, an apartment building, and Parcel 12, a hotel building. He then gave a brief update on the status of the proposed Intermodal Transit Center. Chairman Sherman updated the Commission on the status of the river dredging, and the issue with public access to the Riverwalk, particularly in Waterplace Park, during events. He noted that a group is working to relocate the Wall of Hope.

#### 6. Report on the State Parking Study

Andy Hill of Desman Parking Specialists gave a PowerPoint presentation. Chairman Sherman stated that the next step would be for him to meet with the State administration. He noted that eh study generated good ideas that now need to be implemented. Ms. Joshi commented that the State should offer an amenity instead of an incentive. Chairman Sherman stated that no action would be taken on this item, however, the Commission would continue to discuss.
