THE SUBJECT OF THE PUBLIC HEARING IS WHETHER THE COMMISSION SHOULD CERTIFY BEING FEMALE AS A BONA FIDE OCCUPATIONAL QUALIFICATION (BFOQ) FOR ONE STOREKEEPER POSITION ASSIGNED TO THE KEANEY-MACKAL EQUIPMENT AND LOCKER ROOM IN THE ATHLETIC COMPLEX AT THE UNIVERSITY OF RHODE ISLAND (URI). URI HAS REQUESTED THE CERTIFICATION OF THIS BFOQ.

INTERESTED PERSONS MAY SUBMIT WRITTEN COMMENTS AT OR BEFORE THE PUBLIC HEARING, AND MAY SUBMIT ORAL COMMENTS AT THE PUBLIC HEARING, ON THE QUESTION OF WHETHER THE COMMISSION SHOULD CERTIFY BEING FEMALE AS A BFOQ FOR ONE STOREKEEPER POSITION ASSIGNED TO THE

KEANEY-MACKAL EQUIPMENT AND LOCKER ROOM IN THE ATHLETIC COMPLEX AT URI.

THIS HEARING IS HELD PURSUANT TO RHODE ISLAND GENERAL LAWS SECTION 28-5-7(4).
