**AN ORDINANCE IN AMENDMENT OF CHAPTER 18 OF THE**

**REVISED ORDINANCES OF THE CITY OF EAST PROVIDENCE,  
RHODE ISLAND, 1998, AS AMENDED, ENTITLED  
“VEHICLES AND TRAFFIC.”**

**THE COUNCIL OF THE CITY OF EAST PROVIDENCE HEREBY  
ORDAINS:**

**SECTION I. Subsection (b) of Section 18-315 entitled  
“Same—Handicapped parking.” of Article X entitled “Stopping,  
Standing and Parking.” of Chapter 18 entitled “Vehicles and Traffic.”  
of the Revised Ordinances of the City of East Providence, Rhode  
Island, 1998, as amended, is amended to read as follows:**

**(b) It shall be unlawful for the operator of any vehicle to stand or  
park a vehicle, whether occupied or not, in all other areas in the city  
whether on public or private property when the parking space is  
within the purview of the state building code and is designated as a  
"disability parking space."**

**The Director of Public Works, with prior approval of the City Council,  
is hereby authorized to designate handicapped parking areas and  
shall review same biennially so as**

**to determine if a previously designated area should be removed. The  
Director of Public Works is also hereby authorized to remove a  
handicapped parking area with prior approval of the City Council.**

**Disability parking space shall be designated and identified by the  
posting of signs above ground level incorporating the international  
symbol of access of white and blue, and the words "Handicapped**

**Parking," "Disability Parking," "Disabled Parking" or "Reserved Parking."**

**SECTION II. This ordinance shall take effect upon its second passage and all ordinances or parts of ordinances inconsistent herewith are hereby repealed.**
