Zoning Ordinance Amendment and Zoning Ordinance Text Amendment

A Petition to consider a zoning ordinance amendment received on November 13, 2009 and filed by N.E. Ventures, LLC, 15 Wellstown Rd., Ashaway, RI, with Renova Lighting Systems, Inc. as lessee, for property owned by N.E. Ventures, LLC located at 15 Wellstown Rd. and identified as Assessor's Plat 4 Lot 22 a Manufacturing Zone. The applicant is requesting an amendment to Chapter 134 of the Zoning Ordinances of the Town of Hopkinton, as amended, to allow all manufacturing uses to be permitted on AP 4 Lot 22 so as to remove the restriction imposed by the Town Council on June 4, 2007, specifically Restriction No. 10 which states in part "10(a) That the use

of this property is strictly limited to the light industrial use proposed by the applicant. Specifically, this use shall be, “the design, engineering and assembly of lighting systems”.

Ventures, LLC, 15 Wellstown Rd., Ashaway, RI, with Renova Lighting Systems, Inc. as lessee, for property owned by N.E. Ventures, LLC located at 15 Wellstown Rd. and identified as Assessor’s Plat 4 Lot 22 a Manufacturing Zone. The applicant is requesting an amendment to Chapter 131 “Groundwater and Wellhead Protection Ordinance” to modify Section 5 of the Aquifer Primary Use Table and requesting an amendment to Chapter 134 “Zoning Ordinances” to modify Section 5 District Use Regulations to add a new Use Table category 363 Design, engineering & assembly of lighting systems, electronic equipment & components.
