DECISION RE: ZONING ORDINANCE AMENDMENT/ZONING ORDINANCE LANGUAGE AMENDMENT

Render a decision regarding a Zoning Ordinance Amendment to the Zoning Map and a Zoning Ordinance Language Amendment. The petitions are filed by Christine Austin and Amy Vachon d/b/a The Kids Co. for property located at 1111 Main Street, Hope Valley, RI 02832, property owned by The Phoenix Group, 2 Williams Street, Providence, RI 02903, identified as Assessor's Plat 28 Lot 133 a Neighborhood Business Zone with uses limited to Real Estate Offices or Professional Offices. The applicants request an amendment to the August 5, 1985 Town Council decision that approved a limited use

zone change in a Neighborhood Business Zone, to include a Day Care Center as a permitted use together with the previously approved uses of Real Estate Office and Professional Offices and the applicants request a language amendment to Section 5 District Use Regulations to include a Day Care Center designation as specified below and to request a language amendment to Section 5a Groundwater & Wellhead Protection Ordinance to create a land use category of “Day Care Center” also specified below. The petitions are filed in accordance with Chapter 134, Section 16 of the Zoning Ordinances of the Town of Hopkinton, as amended heard on June 3 and June 17, 2013.
