for the purpose of ordering a tax to be levied and assessed on the ratable property of said town and the inhabitants thereof, for the payment of:

- Town debts and interest
- The payment of the town's proportion of the state tax
- The payment of the Town's share of the support of the Exeter-West Greenwich Regional School District
- The support and maintenance of the poor
- The building, amending and repairing of highways and bridges, oiling of highways and the erection of street signs
- The improvement in any manner deemed fit of any property belonging to the town
- The purchase of highway equipment
- The salaries and expenses necessary and incidental to the operation of the offices of the Town Council, Town Administrator, Town Clerk, Town Treasurer, Tax Assessor, Tax Collector, Town Planner, Town Sergeant, Human Services, Board of Canvassers, Board of Tax Review, Zoning Board of Review, Planning Board, the Building Inspector, Zoning Inspector, Electrical Inspector, Plumbing Inspector, Conservation Commission, Juvenile Hearing Board, Land Trust, Financial Advisory Board, Economic Development Commission, Board of Engineers, Highway Dept., Sanitation Dept., Water Dept., Police Dept., Emergency Management Dept., other town officers and employees.
- The payment of salary of the Town Solicitor and other legal expenses
- The payment of social security taxes and workmen's compensation insurance premiums on wages and salaries of town officers and employees, and costs of certain employee's benefits
- The payment of heat, light, and fuel for town buildings
- The operation of telephone communications and service computer systems, etc
- The payment of insurance on town buildings and property
- The payment of hydrant rentals
- The cost of auditing financial records
- The costs of services of the R.I. Development and the State Department of Community Affairs
- Grants to the Volunteer Fire Companies, Louttit Library, West Greenwich Happy Seniors, West Greenwich Historical Society, Little League, Girls Softball, Exeter-West Greenwich Knights, Youth Basketball, EWG Soccer, The Mishnock Rescue, Hianloland Rescue, West Greenwich Community Rescue Operation, Henry B. Wright Scholarship, EWG-TV, R. I. League of Cities and Towns, and Memorial Day Parade.
- The cost of grant matching
- The maintenance and operation of the Town Transfer Station
- The costs of landfill closure and recycling
- The cost of engineering, mapping and records restoration
- The holding of elective meetings, including primaries
- The cost of funding the sewer design capacity fund, Clean Water Financing Debt Service, and Open Space General Obligation Bond Debt Service
- The cost of funding capital funds for Community & Social Services – Open Space GO Bond Debt Service
- Appropriation of a portion of funds annually collected through the Real Estate Conveyance Fee paid on real estate transfers to the "Open Space Protection Fund".
- For all necessary charges and expenses whatsoever arising within said Town, whether incidental or not to the above.
