CONSERVATION COMMISSION MEETING AGENDA Wednesday, July 28, 2004

On Wednesday, July 28, 2004 at 7:30 p.m., the North Kingstown Conservation Commission will convene at the North Kingstown Town Hall, 80 Boston Neck Road, North Kingstown, relative to the following:

1. Call to order
2. Recommendation: Application by the Quiddnessett Country Club Inc for Farm, Forest and Open Space Designation, Plats 167, Lot 2, Plat 166, Lot 528, and Plat 32, Lot 3.
3. Recommendation: CRMC Modification #1995-06-040 – Assent application of Norman Cook, 171 Steamboat Avenue, Plat 91, Lot 131 & 132, North Kingstown, RI, to construct a modification to an existing residential boating facility by adding a 4' x 15' fixed pier section and two (2) 4' x 24' fingers totaling 192 square feet for small boat dockage. The terminus of the dock will extend 73' beyond mean low water. A 42 square foot float and a 23' length variance are required.
4. Recommendation: CRMC #2004-06-056 – Assent application of Anthony and Maria Barone, 32 Concord Avenue, Plat 91, Lot 105, North Kingstown, RI, to construct and maintain a residential boating facility consisting of 4' x 51' and 4' x 20' fixed timber pier sections in approximately an "L" configuration, and two timber tie-off piles approximately 17' seaward of the pier terminus. The proposal includes renovation and partial reconstruction of the existing stone groin.
5. Recommendation: Preliminary application by the RIDOT to make improvements to Post Road and Stony Lane. Portions of this work will take place within 25' of North Kingstown Historical Cemetery No. 57. This work will include grading activities as well as loam and seeding in the area abutting the north side of the cemetery as well as the installation of a utility pole and associated anchoring guy pole.
