## **COMPREHENSIVE PLAN AMENDMENT**

**Notice is hereby given pursuant to Rhode Island General Laws 45-22.2-12, that a public hearing will be held on Monday, November 22, 2004 at 7:00 P.M., in the West Greenwich Town Hall, 280 Victory Highway, West Greenwich, Rhode Island to consider an ordinance amending the Housing Element of the Comprehensive Plan of the Town of West Greenwich. For the purposes of this public hearing the Town Council and the Planning Board will convene in joint session.**

**The Town Council and the Planning Board of the Town of West Greenwich proposes that the Housing Element of the Comprehensive Plan of the Town of West Greenwich be amended to include the State of Rhode Island mandated Affordable Housing Plan which consists of revised demographics, identification of local housing needs, a framework for creating and preserving affordable housing opportunities, an action plan and strategies with respect to meeting the State's 10% affordable housing standard.**

**All interested parties may review and examine a copy of the proposed Comprehensive Plan amendment at the West Greenwich Town Clerk's Office between the hours of 9:00 a.m. to 4:00 p.m. and at the Public Library during library hours. Copies of the proposed Comprehensive Plan amendment can be obtained at the Town Clerk's Office.**

**At the public hearing opportunity shall be given to all persons**

**interested to be heard upon the matter of the proposed amendment. The proposal may be altered or amended prior to the close of the public hearing without further advertising, as a result of further study or because of the views expressed at the public hearing. Any such alteration or amendment must be presented for comment in the course of said hearing.**
