**3. McKinley's Foot of the Hill Tavern (Tabled from 10/14/08)**

**In that on September 30, 2008 at approximately 2:13a.m., while on**

**routine patrol, Officer Walker went to 1 Division Street, McKinley's Pub for a liquor check. Upon doing so, Officer Walker observed bar employees inside working. Officer Walker entered the establishment and spoke with the three employees. All were cleaning up and attempting to locate money that their register was short. The staff explained to Officer Walker that they had called for an extension and had been denied. Officer Walker had been at the establishment at 1:37 a.m. and saw an employee seated at the bar with a draft beer in front of him. The Officer had advised the staff at that time to leave by 2:00 a.m.**

**Due to the aforementioned facts, the management of, McKinley's Pub, 1 Division Street, East Greenwich, is in violation of the following rules and regulations issued by the Board of Public Safety for the orderly operation of liquor establishments.**

**Article #9 Clearance of Premises and Associated Areas:**

**A. All patrons shall leave the licensed premises within one-half hour after the required closing time, and all employees shall leave the licensed premises within one hour after the required closing time, and all employees and patrons shall leave the associated parking and outside areas within one hour after the required closing time.**

**C. No alcoholic beverages shall be consumed by the licensee or employees after**

**the required closing time.**

**On October 2, 2008 Sergeant DeFeo responded to the Sports Legend Pub, 2121 West Shore Rd. in order to follow up on the liquor law violation aspect of the assault that had occurred there the previous night. Upon arriving at the club Sergeant DeFeo met with the bartender, Heather Clark. Sergeant DeFeo asked the bartender what had occurred the night before at which time she stated that her girlfriend had gotten into an argument with her boyfriend and that she had separated the two of them. About 10 minutes later the argument started up again. She stated that the male had pushed the female and it was at this time that the female threw a plastic cup at the male's head cutting his ear and he had stated that he did not want to call the Police. The bartender then took the male into the back room to clean his ear at which time he proceeded to say he did not want the police involved. Ms. Clark stated to the Sergeant that at no point in time did she call the police and she did state that the reason why was because she was friendly with the two subjects involved and did not think it was necessary. She was advised along with the owner's son that the**

report would be forwarded to the Board of Public Safety. (08-4676 OF)
