**“On October 4, 2013 at 0246 hours I, Officer Petit, placed myself on a liquor check at the Grid Iron Ale House and Grille, 1599 Post Road.**

**While on patrol I observed numerous persons inside the establishment after hours.**

**I met with the manager Randall Jacob DOB 4/16/76 inside the establishment. He was located in a back room behind the bar. He stated that he was “hanging out.” He was warned and advised that he has to leave the establishment by 0200 hours. It should be noted that Jacob was previously warned on July 30, 2013 for being inside the establishment after hours. The beverage license number issued by the City of Warwick is #BV055.**

**The other persons in the establishment were the cleaning crew, which consisted of a male and two females. They were observed cleaning the establishment. I was advised by Jacob that the cleaning crew regularly shows up after hours as instructed by him.**

**This report will be forwarded to the Licensing Division.”**

**Due to the aforementioned facts the management of Grid Iron Ale House & Grille is in violation of the following rules and regulations issued by the Board of Public Safety for the orderly operation of liquor establishments.**

## **9. CLEARANCE OF PREMISE AND ASSOCIATED AREAS:**

**A. All patrons shall leave the licensed premise within one-half hour after the required closing time, and all employees and patrons shall leave the parking and outside areas within one hour after the required closing time.**

#### **5. Nostalgia Grill & Lounge (Liquor License Violation) – October 24, 2013**

**“On October 24, 2013, at approximately 0226 hours, Officer Waddington was on routine patrol when he observed two vehicles still parked in front of the Nostalgia Grill and Lounge at 557 Warwick Avenue.**

**At that time, Officer Waddington pulled into the lot, approached the front of the building, and flashed his flashlight inside of the building. Officer Waddington did observe one male sitting at the bar and one male behind the bar. There did not appear to be any alcohol on that bar at that time, but they were inside the establishment after the 2:00 a.m. closing.**

**Officer Waddington did make contact with the two males, one who was identified as Jason Nadeau (DOB 11/19/75). He stated that he was the bar manager and he did state that they were having problems closing down the register. The second male was identified as Joseph Burton (DOB 8/29/69). Officer Waddington did not observe the males to be near the cash register.**

**At that time, Officer Waddington did ask Jason Nadeau if he had called the Officer In Charge for an extension after the 2:00 a.m. closing, to which he stated he did not. Officer Waddington did confirm this with Dispatch that an extension had not been called in. At that time, Officer Waddington did advise them that they would be violated in reference to their liquor license. Officer Waddington did observe the City of Warwick Class B liquor license hanging on the wall (license #BV-017 with an expiration date of 12/01/13).**

**Officer Waddington did advise them that they needed to lock and leave the premise. Officer Waddington did also advise that they would be contacted by Licensing in reference to the violation.”**

**Due to the aforementioned facts the management of Nostalgia Grill and Lounge is in violation of the following rules and regulations issued by the Board of Public Safety for the orderly operation of liquor establishments.**
