

Show Cause Hearing: Class ED: EDX: Finnegan’s Draft House, Inc. 395-397 Westminster Street: Violation of: an incident that occurred on November 11, 2005. As police were at the establishment they observed a fight between two patrons. As the officers attempted to intervene, a third subject grabbed hold of one of the officer’s firearms and attempted to remove it from the holster. That subject was apprehended after a violent struggle and charged with simple assault, disorderly conduct and resisting arrest; At that same time police also apprehended another subject for failure to move after he refused police orders to disperse. The bar was closed down for business at that time and police, under the supervision of Lt. Lee, counted 249 patrons exit; The club capacity is posted at 196; It should also be noted that the establishment stored its tables and chairs on the sidewalk outside of the Westminster Street side of the Building.

For Decision: Class ED: EDX: Chapinlandia Restaurant, Inc. 319 Pocasset Avenue; Violation of; loud music on November 17, 2005 at approximately 1:30 AM. On that date police responded to that location and spoke with the owner regarding loud music. The owner appeared to be highly intoxicated and was uncooperative with police. On that same date at approximately 2:30 AM Police again responded there and people inside the establishment drinking alcohol; Again, the owner, who appeared to be highly intoxicated was uncooperative with police.






