

Show Cause Hearing: A.A.T. Restaurant, Corp; d/b/a Pulse, 86 Crary Street; Violation of; a fight that erupted inside the establishment on the dance floor area between females; shortly afterward a second disturbance took place involving a large group of males; they were removed by the club security staff. The group again began to fight while in the parking lot and were dispersed by police; minutes later, the group, who had left the parking area were observed returning towards the club and advance towards police. Additional officers from around the city were called to respond to assist the detail officers; while officers were responding to the disturbance they observed two males standing on the corner of Frank and Beacon Streets; one of the males was stuffing a chrome revolver in the front of his pants waistband; the subjects were apprehended after a foot chase and charged; on to wit: November 24, 2005.
