For Decision: Class B/BX, Class N, Food Dispenser and Holiday Licenses; Tomasso Bar & Grille, Inc., d/b/a Bar One, 1 Throop Alley, for violation of disorderly behavior stemming from the bar:

On May 19, 2006, a subject was arrested for fighting after exiting the Bar. Rhode Island State Police also assisted in the arrest. Refer to CCR #06-555317.

On June 9, 2006, Police observed a disturbance in the parking lot and several male subjects sustained injuries to the facial area. The victims stated they were attacked by several males while attempting to leave the bar. The victim who is 20 years old also stated he was served alcohol while inside Bar One. Refer to CCR #06-65568.

On June 10, 2006, based on an allegation stemming from the June 9th incident, the License Enforcement Unit conducted a routine inspection of Bar One and arrested two subjects for Possession of a Beverage – Underage Person, RIGL 3-8-10. Refer to Police Report #06-67559.

On June 16, 2006, Police responded to the bar for an assault. Police spoke with the victim who stated he was jumped by 5 subjects. Refer to Police Report #06-68812.


