There has been and continues to be numerous issues with public drinking and drunkenness, fights, illegal parking, and excessively loud music. This venue continues to be a disruption and public safety threat to surrounding residents and businesses.

Therefore, due to the fact that the restaurant is located in a stable mixed use area in close proximity to numerous residences and, considering the ongoing violations, granting this renewal would continue to negatively affect the quality of life for these residents.

As the councilman representing Ward 6, and seeing no justification for the renewal of this license, I oppose the renewal.

I respectfully ask that you deny the renewal. Thank you.
