1. **CASE 13.062 ■ 215 DEAN STREET, V.N. Famiglietti, Broadway Garage, c1910 (BROADWAY)**
The applicant is requesting the modification of the existing front elevation.
2. **CASE 13.129 ■ 129 WILLIAMS STREET, Uriah Baker House, 1844 (COLLEGE HILL)**
The applicant is requesting the conversion of a window to a door and the construction of stairs and a landing, rear elevation.
3. **CASE 13.136 ■ 43 BENEFIT STREET, Joseph Jenckes House, 1774 (COLLEGE HILL)**
The applicant is requesting the demolition of the existing two-bay garage; modifications to the main house to include removal of an existing door and restoration of window opening, installation of window and door, east elevation, rear el; restoration of window openings and installation of double door, rear (east) elevation; removal of window and installation of double door, north elevation; relocation of bulkhead from east to north elevation.
4. **CASE 13.138 ■ 36 ARNOLD STREET, Nathan Mason House, ca. 1841 (COLLEGE HILL)**
The applicant is requesting the construction of dormers, east and west slopes of roof, a roof-top deck, on the one-story rear ell, the construction of a stair from deck to ground level, west elevation and assorted window modifications.
