The visitor parking for Quality Partners of Rhode Island is in Lot A or Lot F, just past our building on Promenade St. The easiest way to get to our offices from visitor parking is to walk up the side street (Holden) to the rear entrance. As you enter the building there will be a set of elevators in the lobby on your right. Take the elevator to the 5th floor and turn right when you exit.

95 South/Route 146 South

- Follow Interstate 95 South or Route 146 South toward Providence.
- Take Exit 22C off of 95 South – Providence Place.
- Take a right onto Kinsley Avenue/Providence Place.
- Go to end, and make a U-shaped turn onto Promenade Street, crossing over river and under Rte 95.
- The very first brick building on the right is our building.
- Proceed to Visitor Parking.
- Please read above for entrance instructions.

95 North

- Follow Interstate 95 North toward Providence.
- Take Exit 22C – Providence Place.
- Take a right onto Kinsley Avenue/Providence Place.
- Go to end, and make a U-shaped turn onto Promenade Street, crossing over river and under Rte 95.
- The very first brick building on the right is our building.
- Proceed to Visitor Parking.
- Please read above for entrance instructions.

Route 6 East

- Follow Route 6 to Route 10 toward Providence.
- Take the Dean Street/Atwells Avenue Exit off Route 10.
- Turn left at the end of the exit onto Dean Street.
- Go to second light at bottom of the hill and turn right onto Kinsley Avenue/Providence Place.
- Go to end, and make a U-shaped turn onto Promenade Street, crossing over river and under Rte 95.
- The very first brick building on the right is our building.
- Proceed to Visitor Parking.
